Explanation of national provisions:

Declarations of public cultural interest were enacted through the National legislative decree n. 42/2004, for the following types of properties:

at Art. 10 comma 1:

Properties as a cultural asset to the state, to the regions, to other local government agencies, as well as to every other public body and institution and private non-profit legal persons, including civilly recognized ecclesiastical bodies, which have artistic interest, historical, archaeological or ethno-anthropological.

at Art. 10, comma 3,:

(a) property which has a particularly important artistic, historical, archaeological or ethno-anthropological interest, also belonging to private subjects

...

(d) property, of particular interest because of their connection with political, military, literature, art, science, technology, industry and culture in general, or what testimonies of the identity and history of public, collective, or religious institutions;
